Security Improvement and Infrastructure Capital Project - On June 9, 2020, the Williamsville Central School District received approval from its community to construct all items associated with the District-wide Security Improvement and Infrastructure project. The District had worked with the architects and construction manager to develop detailed construction documents that were sent to the New York State Education Department for review and approval in July 2021. This past October 2021, we received approval from the New York State Education Department to proceed with all aspects of the capital project.

#### Security project work (Roof work)

This summer's construction has seen roof replacement at North, Country Parkway, Forest, and Maple East. The work resulted in the replacement of 378,000 square feet of roofs. Overall, there were five full workdays lost to weather this summer. Roofing crews were able to work Saturdays in August to make-up for some of the lost days. When students returned to school, approximately 95% of the roof work was complete. The remaining work should take between five to ten work days to complete in the month of September. The amount of roofing replacement we completed this summer was never before attempted and its completion will preserve these school buildings for the next twenty years.

#### Security project work (security vestibule and main office renovation)

The District began the 2022-23 school year with new security entrances at Country Parkway Elementary, Mill Middle, Casey Middle, South High, Maple East Elementary, and Forest Elementary schools. The security entrances have segregated visitors into a secured space where a face-to-face conversation will occur with a school representative. A visitor may be allowed to move into the school office from the secured waiting area if they are granted this access by a representative of the school. In addition to the new secured vestibule, our construction also included the redesign of school office space at these schools. The degree of redesign varied by school. At the elementary schools and Mill Middle school, an office suite concept was constructed that locates the school main office, principal, nurse, and attendance areas into these new spaces. Most importantly, access to all of these spaces is contained within the suite. Hallway doors from this suite area may be closed by the school to provide even greater security if it becomes necessary to do so. Another important upgrade for these schools was the installation of a new school lockdown system. The first phase of this system was installed over the summer. The system includes lockdown pull stations that are positioned throughout school hallways. The system also includes an integrated clock/messaging system located in hallways and in every classroom. If activated, this system automatically notifies the school staff/students of a lockdown, secures the school and informs the appropriate authorities of the situation.

#### Security project work (phase 2 - summer of 2023)

The work scheduled for the summer of 2023 will be reviewed by our construction team in September 2022. The District will contact the schools impacted by construction and review the start dates in early October 2022. The District will follow the same construction timeline used for the first phase of construction with major construction work beginning with the spring recess and continuing through the remaining months of the 2022-23 school year. Construction will occur at Dodge, Maple West and Heim Elementary schools. The middle school construction work will be at Heim and Transit. High school construction will be at East and North.
